

## The WTSC Call for Test Participants:

The Wireless Number Portability Operations (WNPO) Team and its reporting committee the Wireless Test Sub-Committee (WTSC) is seeking additional test participants from both wireless and wireline carriers for Local Number Portability May 24<sup>th</sup>, 2004 launch date. Testing is essential to ensure system efficiencies between trading partners during the porting process and to guarantee customer satisfaction.

The Wireless Operations Team provides a forum for the identification, discussion and resolution of issues affecting Service Provider Operational groups in their mandated implementations for Service Provider Local Number Portability (LNP) within their respective companies. The Team will give on-going support to LNP activities from an operations perspective. This includes the identification of existing or potential gaps between Service Provider implementation of regional and/or national guidelines and associated resolutions or remedies.

The Wireless Testing Subcommittee (WTSC) is focused on forming and implementing a testing framework that enables Service Provider Testing Representatives to work directly with each other to complete inter-carrier porting testing in a timely and efficient manner. The Subcommittee will give on-going support to all LNP testing activities. This includes the identification of existing or potential gaps and/or conflicts in communication between Service Providers and/or the NPAC. The team will provide recommendations and/or solutions within its committee and to its reporting committee, the WNPO.

WTSC is currently reviewing lessons learned from the 11/24/03 launch date and will incorporate, as necessary, these items into new test cases or scenarios. Based on past experience WTSC participants encourage carriers to begin making contacts and testing with trading partners as early as possible and no later than March 1<sup>st</sup>.
