**4.6 Global Title Translation /SMS****4.6.2 SMS (Text Message) INTRA-CARRIER while roaming*****E-mail to a Ported Number while roaming******Test Description:***

*This will test that an e-mail originated text message is delivered to an Intra-Carrier MS wireless ported number roaming in another carrier mkt. SMS delivery of text messages should include the appropriate Global Title Translations, SMSC and STP datafill.*

***Test Procedure***

1. *Send an e-mail text message to a roaming wireless ported number.*
2. *Verify MC uses MDN in SMSREQ to resolve SMS\_Address of destination MS.*
3. *Verify MT SMDPP includes SMS\_Delivery message and mandatory parameters.*
4. *Verify MT SMDPP ODA is MSID of destination MS.*
5. *Verify MSID parameter is properly identified.*
6. *Verify message delivered to destination.*
7. *Verify message "from" address is e-mail address.*
