**Industry update**

IITC – asks how many GETS (Govt emergency tel. #s) we need for testing. We will follow up with IITC for clarification on purpose of this test.

From Jim Grasser –

WNPO's risk document will be sent to FCC asking them to get directly involved (bypassing the NANC) if the rollout of WLNP is in jeopardy.

ICP document is not related to pooling and should not impact testing

NNPO or OBF flows for resellers (support NNPO) – wireline porting only

Issue of reseller flow should not impact testing.

Wireline carriers looking for a wireless test schedule to know when to be ready to test afterward.

**Action Item Review**

WTSC Non-document

#13 – Inter-carrier test guidelines has been modified. We will review in more detail in Atlanta.

**WNPO**

#2 - Wireline SOAs do not populate actual time of port. Issue is being discussed at LNPA. Proposal for wireline carriers to submit SOA activation differently based on port to wireline or wireless carrier.

#3 – WNPO will submit a letter on behalf of WTSC to LLC asking that the regions for upgrading NPAC release 3.1 are not changed. NPAC 3.1 upgrades are scheduled between Feb 2002 and May 2002. Regions have not been assigned yet. By keeping the regions in place, the WTSC and associated SPs can test on a few regions on NPAC version 2.0 and the rest on version 3.1.

NOTE – Version of NPAC software should have no direct impact on inter-carrier testing.
